  - o Anticipated Timeline: Journal submission in Spring 2023
  - Progress: Significant writing revisions completed in January 2023 through feedback from colleagues and copy editor
  - O Summary: I examine the relationship between intra-quarter news releases and quarterly earnings. I find that investors are able to use these news releases to predict quarterly earnings, shown through a reduction in market reaction to a given level of earnings surprise, and to be able to understand the quarterly earnings surprise more accurately, shown through a reduction in post-earnings announcement drift.

  - o *Anticipated Timeline:* Completing data analysis in Spring 2023, working paper in Summer 2023, and journal submission by Winter 2023.
  - o *Progress:* Data collection complete (1500 observations) and preliminary data analysis done
  - Summary: Given recent regulation changes in 2018, we find significant variation of smaller reporting companies that voluntarily disclose pay ratios. This variation allows us to test the effects of this particular disclosure using this unique setting

- **Deng, Justin**, Ivo Jansen, and Jun Guo. The value of financial expertise in the audit committee. Looking at the unique corporate governance practices of smaller reporting companies
  - o *Anticipated Timeline:* Completing data collection in Spring 2023, data analysis in Summer 2023, working paper in Fall 2023, and journal submission by Summer 2024.
  - o *Progress:* Data collection in progress (~300 observations collected out of 1500)
  - Summary: Smaller reporting companies is an under-researched area given lack of data provided by data vendors. Using a hand-collected dataset, we investigate the corporate governance practices of smaller reporting companies and find variation in the presence of financial expertise in audit committees, despite it being required for all other public companies. Using this unique setting, we can investigate whether financial expertise affects financial reporting outcomes.
- **Deng, Justin**. Do firms that disclose more make better investments?
  - O Anticipated Timeline: Comprehensive data analysis by Summer 2023, working paper by Winter 2023, and journal submission by Summer 2024
  - o *Progress:* Preliminary data analysis done with promising early results
  - Summary: I find that firms that have more news releases or Form 8-Ks have higher investment quality. I hypothesize that firms use the stock market feedback from their disclosures to guide their future investment decisions
