COURSE DESCRIPTION:

This is an introductory course dealing with legal principles and procedures and an introduction to contract law. Along with learning the basics of our legal foundation, case studies will be used to apply knowledge gained.

COURSE LEARNING OBJECTIVES:

Every day of our lives we are involved in business transactions: when we buy a newspaper, a meal, groceries, an automobile, or write a check. The primary purpose of this course, therefore, is to develop an understanding of the legal framework of business- the basic principles of the law that apply to business transactions. The course will equip you with the necessary knowledge and ability to use various tools for analysis and problem-solving.

Program Learning Goals:

• Students will be able to critically use information and data to analyze, interpret and solve business problem as it pertains to the law.

- Students will demonstrate an ability to identify and analyze global factors (political
 economic, culture, legal, demographic) that impact the management of business
 operations in the global environment.
- Students will realize that organizations and their actions affect different stakeholders; they will demonstrate the ability to identify and weigh the ethical implications of these actions.

How to Study: Read the chapter's objectives, and Questions at the end of the chapter, before you begin to read the chapter. Read the chapter and complete all homework before class.

ATTENDANCE POLICY/CLASS PARTICIPATION:

Attendance will be taken during each class. If there are assigned seats, you should sit in your assigned seat every class. Attendance is defined as being in the classroom on time and prepared for every class session. Students are expected to have read the assigned chapter(s) prior to class each week in order to be prepared for class discussion. Paying attention to the lecture and not disrupting/disturbing the professor, guest lecturers or other students is also considered to be part of attendance. Just being here is NOT enough! When you are asked a question, you must respond. I don't know, or silence will not garner any points for class participation. You must participate in group activities as they are assigned.

Late arrivals must check in with me at the end of class to insure they are not marked absent. In order to avoid an unexcused absence, you must inform me via email or telephone before the class you will miss. Class participation is a critical part of the course and requires you to attend class. Education is NOT a one-way street! You are required to be a part of the educational process!

MOCK TRIAL:

Each student will be expected to participate in the Mock Trial. Students will either be lawyers, judges, jurors, witnesses, or some other participant. Guidelines for the trial will be disseminated later. The Mock Trial will occur during the time scheduled for your final at the Moot Court Room at the Law School.

RESPONSIBILITIES FOR COMPLETION OF MISSED COURSE REQUIREMENTS:

A student must complete all course work missed because of absence. The student will contact the faculty member to make reasonable arrangements for the completion of course requirements not completed because of student absence due to one or more types of excused absences.

Missed exams can be made up only with a verifiable doctor's note or special approval from me. Special approval will not be considered unless you speak to and e-mail me prior to the exam you expect to miss.

PLAGIARISM

Plagiarism will not be tolerated under any circumstances. Be aware that plagiarism includes (but is not limited to) copying someone else's words without crediting the source; paraphrasing someone else's words without crediting the source; using someone else's ideas without crediting the source (even if rephrased in your own words); using facts not universally known which are obtained from a source without crediting the source; asking someone else to write your paper, either in whole or in part; or obtaining a paper or portion thereof by any means and submitting it as an original document. The penalty for plagiarism is failure of the assignment and potentially failure of the course (at the instructor's discretion), and it may result in suspension or expulsion from the University.
